

What is the FREE Reverse Marking Service?

- * Every time you use a lead retrieval device (available for purchase at an additional cost) to scan attendee's badge at the expo, a link is created between you and the attendee.
- * After the show Every attendee will receive and email linked to their own unique webpage listing all exhibitors that they visited by service category.
- * Jump-start your post-show marketing by giving your company "top-of-mind awareness" when you contact them after the event.
